If there are 4 general wards this gives a maori voter the option to only vote for 4 councilors. Whereas any other voter will be able to vote for 7. This is totally unfair and undemocratic. As maori are part of the whole community too, maori deserve a say on all who are elected to office. I understand that the MDC might be hamstrung by the Government in this matter but it is the councils duty of care under the Treaty of Waitangi to protect the rights of maori. Clearly if the proposal is for more than one general ward in the make up of the council the council is not protecting the voting rights of the maori voters.

Therefore the council should proceed as per this proposal with only one general ward and if the Government were to disagree then the council should take the matter to the courts in the interest of the maori voters of this district.

I am very concerned at the central governments attempts to bring in two tier legal & health systems and I want reassurance that this is NOT going to happen in the Council. If it does, ie Maoris or matters effecting them, are given more importance than everything else. This must not happen otherwise it undermines local democracy. They have the same rights as everyone else does in the community, and we must make sure it isn't diluted or magnified as being more or less important.

Introduction

We appreciate the opportunity to give feedback on Masterton District Councils Representation Review. Councils play an important role in ensuring our communities include everyone. A key part of this is ensuring that councils are accessible and fully inclusive so all voices across communities are heard. Improved Representation strengthens communities, by ensuring everyone can participate. Improved representation also improves diversity helping ensure the long term sustainability of issues such as Access across communities in which Disabled people live work and connect.

How we live work and connect affects everyone's wellbeing but experiences we have are not equal for everyone. On 28th October Stats NZ released new data on disability that confirms almost one in four New Zealanders are disabled.

We encourage Council to consider a reduction in costs associated with Standing and Serving on Council with greater emphasis on the needs of all their citizens. Statistics of Representation of people with Disabilities and Impairments across Local Body politics is extremely poor despite this sector of society being almost a quarter of the population.

You will note that although I am an independent Access Contractor, I would encourage Masterton District Council to take a holistic view of the term 'Access' when thinking about Representation. I believe as Disabled people we already experience enough barriers to inclusion and fair representation within our community.

Removing barriers faced by Disabled People such as economic constraints would encourage involvement of people with Disabilities in democracies such as Councils so I believe the removal of Wards would be beneficial creating greater opportunities for more diverse Communities of Interest to be represented when considering council business.

Taking these actions would create a more equitable opportunity for Disabled people to be represented around the Council Table.

Disabled New Zealanders contribute across all aspects of communities and society but are often excluded from equal opportunities compared to Able Bodied Peers

In the 2013 Disability Survey, disabled people compared to non-disabled people:

- were more likely to have no qualification and less likely to have a University Level Qualification or Education
- have higher unemployment and lower labour force participation.
- have lower incomes and live in lower-income households.
- were less likely to report a high level of life satisfaction.
- > were less likely to feel safe at home or in their neighbourhood.
- were twice as likely to be the victim of violent crime.
- ➤ In the 2018 General Social Survey, disabled people under 65 compared to non-disabled people the same age:
- > were more likely to experience material hardship.
- were more likely to say their housing was very unaffordable.
- were more likely to report being discriminated against.
- were more likely to rate their life satisfaction as a 6 or below (on a scale where 10 is the highest).
- were more likely to rate the wellbeing of their family as a 6 or below (on a scale where 10 is the highest); and were almost twice as likely to report being discriminated against

A major component of CCS Disability Action's mahi is Mobility Parking and the operation of the Mobility Parking Scheme. Representation at council level would allow us to advocate on issues such as these, creating a more inclusive community. We would like to see more Mobility Parks throughout the towns of the region. Currently a lack of mobility car parks, plays a role in isolating people from their community and preventing them from accessing work, social, and educational opportunities.

Planning for access

It is important to consider access issues when planning how our communities and transport systems develop.

Accessibility is an on-going goal rather than a set of minimal standards to be complied with. There is always room for improvement, especially as new and innovative approaches are constantly being developed.

We note that throughout Masterton District Council's Representation Review alternatives are not clearly presented to the proposed review. Whatever decision is made to proceed, we ask Masterton District Council to empower the Disability Sector and make this town the blueprint for accessible representation by making this community more accessible into the future.

Although I was disappointed with the Masterton District Councils decision to defer the Masterton Revamp Project, I look forward to continuing to work alongside Council ensuring accountability regarding issues that affect Disabled people CCS Disability Action supports

Summary:

- We support the principals driving this Review, being mindful of the past as we move into the future. Please be mindful and continue to consult with the Disability Sector and organizations such as CCS Disability Action regarding Access issues, including those below which were identified in Masterton District Councils Long Term Plan
 - Funding for a new civic facility.
 - More Accessible Housing

We congratulate Council for having disability represented in the photos and the body of this document.

- We would like to see access continue to be a high-level priority to Masterton District Council
- ➤ It is important to establish and therefore maintain the connection to the 25% of the community who experience disability and particularly for children and youth with disability. They are our future leaders

Recommendations:

 Masterton District Council develop and expand on the goals of an engaged and empowered community. Masterton/Whakaoriori is a positive, strong, inclusive, diversely represented, self-determining community, with equitable opportunities for everyone leaving no one behind.

For Masterton District Council to be a truly inclusive Council, we would recommend the adoption of an inclusion policy across all areas of council work. Where possible this should include information being provided in a number of different ways, for example in Easy Read Format, providing opportunity for people with cognitive difficulties to be included in any consultation processes.

It is also important to consider that many people who experience living with a disability or impairment may not always have access to technology due to a number of factors, therefore excluding some members of this community having their say.

- Masterton District Council works collaboratively with the disability sector to progressively identify barriers to representation within local government in the community and remove them.
- 3. We recommend that Council continue to provide Mobility Parking Spaces, with an increased provision of these spaces
- 4. To ensure greater representation of people with disabilities or impairments across local body politics, the establishment of a General Ward is encouraged, CCS

Disability Action constantly strives to include all people and therefore as an organization we continue to embark on a fully inclusive bicultural journey

- 5. We believe people with Disabilities and Impairments have abilities. As we work towards a fully inclusive council working with community boards should be recommended and encouraged
- 6. We believe the cost associated with standing for councils should be lowered allowing people with a disability or impairment to stand for council, join in democracy, representing the people and the issues important to the 25% of the population who identify as disabled.

About us.

CCS Disability Action is a community organisation that has been advocating for disabled people to be included in the community since 1935. We provide direct support to approximately 5,000 children, young people and adults through our 18 branches, which operate from Northland to Invercargill. Our support focuses on breaking down barriers to participation. We receive a mixture of government and private funding.

CCS Disability Action has a national network of access coordinators, who work with local government and transport operators to create a more inclusive society. We also run New Zealand's nation-wide Mobility Parking Permit scheme. This scheme currently supports more than 150,000 people to more easily access their communities and facilities. Our fully owned subsidiary, Lifetime Design Ltd, advocates for and provides universal design guidelines to improve the accessibility of New Zealand housing.

We have developed an accessibility app called Access Aware. We are a member of the Access Alliance, which is pushing for a new Access Law. We manage Lifemark, which certifies and promotes universal design standards for houses. We have developed ways to collect data on access, including the Measuring Accessible Journeys project and the Street Accessibility Audits

Conclusion.

Masterton District Council has a vital role in ensuring the growing number of people with access needs can participate, contribute, and be included in their communities. Unless council proactively ensures the accessibility of the community, we risk cutting more and more people off from their community and the services they require to live their daily lives. The impact of the aging population growth will bring an increase in the numbers of people with impairments and increase the need for Universal Design standards and the ability to make Accessible Journeys. Access, Representation of voices of persons with Disabilities and impairments ensuring full Inclusion is needed within Councils.

NUMBER OF COUNCILLORS

I agree with a reduction in Councillor numbers and the reasons given in the Review Proposal

I would like Council to consider reducing the number of elected Councillors to 6 or 7 and appointing 1 if not 2 persons to the Council from the community. These appointees should bring to Council a strong perspective on governance and business to ensure that any areas of expertise that is not covered by elected Councillors can be added to the Council

An example of benefit would be the current position Council finds itself facing with a fractured community on the Civic Centre proposal and the associated decision that need clarity on funding, engineering, consultation etc.

Carefully selected Appointees with skills from involvement with careers in large businesses would be invaluable to our Council and community

It is worth noting that 7 Directors govern Fletcher Challenge that has a \$4 billion annual revenue All of these Directors would bring a range of skills to the Board

One of the disadvantages of Community elections is that the above principle does not apply to the election process.

Another area that should be considered for elected Councillors (or even all persons standing for Local Bodies) is to better prepare them for their role in governing the community. There should be a compulsory programme of induction into programmes from Institute of Directors (for example) Costs shared by Council and Councillors (life time benefit for the individuals)

Masterton District Council (MDC) Representation Review - MRRA's View

Do you agree with our proposal to have eight Councillors?

A MRRA representative attended the community workshop in August to gain an understanding of MDC's proposal. We canvassed our members for their views with this proposal which attracted mixed comments. The recurring theme that came through suggested MDC should maintain ten Councillors. To form a majority view, we put together a survey that consisted of two options.

Option 1 MDC Proposal

The proposal is for a Council of eight elected members, down from the current ten, plus the Mayor, with four Councillors elected from a General Ward, one Councillor elected from a Māori Ward, and the remaining three elected 'At Large'.

What this looks like.

8 Councillors (Plus the Mayor)

- 1 Councillor elected from a Māori Ward (only Māori roll voters)
- 4 Councillors elected from a General Ward, (only general roll voters)
- 3 elected 'At Large' (all voters)

Option 2 - Alternative View

In order to ensure the broad spectrum of Council portfolios are covered adequately, Councillor numbers should be maintained at ten and derived as follows:

What this looks like.

10 Councillors (Plus the Mayor)

- 1 Councillor elected from a Māori Ward (only Māori roll voters)
- 5 Councillors elected from a General Ward, (only general roll voters)
- 4 elected 'At Large' (all voters)

We looked at both options using the formula set out in *Local Electoral Act 2001, Schedule 1A Provisions relating to Māori Wards and Māori Constituencies*. It was concluded both options require only one Māori Councillor.

- Option 1 (0.87 of a Councillor) fraction to be rounding up
- Option 2 (1.02 of a Councillor) fraction disregarded

Any candidate can stand to be elected in either one of the Wards or 'At Large', offering Māori representation to extend beyond the Māori Ward should a candidate want to stand for the General Ward or 'At Large'.

In summary the MRRA support to *maintain the status quo* and remain with ten Councillors.

Do you agree with the mixed arrangement of one Masterton General Ward, one Masterton Māori Ward, and 'At Large'?

There was some commentary on the mix of Wards suggesting one Māori and one General only or one Māori and the remainder 'At Large'. It is noted that if a Māori Ward is established a General Ward is required. On these grounds the ratio of Wards and 'At Large' are a fair representation of the population.

Do you agree with our proposal not to establish Community Boards?

MDC covers a broad range of areas from urban, rural to coastal. While each area has its own unique challenges, we believe it is the responsibility of Council to meet the service delivery requirements of each area. Community Boards are only required where Council and Councillors cannot effectively conduct business and represent the best interests of all areas of our district. MRRA agrees with the proposal not to establish Community Boards on the grounds that the 2022 elected Council maintain effective communication and consultation with the community to ensure they are making decisions that are delivering products and services based on the majority needs of ratepayers and residents.

I would prefer to have only two wards, Māori and General with voting based on which roll you are on, same as for the general election.

It's a disgrace that our hard-won democracy is being taken from us and replaced with a race based election system.

If either option is accepted by Council, the two Iwi representatives should be discontinued, otherwise Māori would have disproportionate representation.

I would prefer that the 9 Councillors come from "1 ward" personally I cannot see the point of 2 wards.

Due to the diversity of our region and the importance of upcoming issues the Council will need to vote on, I feel keeping with the current number of Councillors is appropriate. I do not feel the increase in remuneration through reducing by two Councillors is likely to attract a higher calibre/more diverse range of people to the role. We have no strong evidence those Councils that have eight Councillors attract better and more diverse people, do we? It's possibly a bit insulting to the current Councillors to have this as a driver? It seems for the Wairarapa, the role is not full time (a number of Councillors do part or full time work or other voluntary work as well as their Councillor role). Reducing the number of Councillors would increase the workload and may make it more difficult to attract those that want to serve in the role, but also need to work as well to make it financially viable for their families. Also it seems other Councils similar to Masterton may have eight Councillors, however some also have the same or more.

I would like to see the ten, but at a better or same rate of remuneration as the proposal for eight. Due to the time it takes to familiarize incoming Councillors we should have better continuity with ten to start with, giving more overlap during the various periods each Councillor is elected for. And hence hopefully better coverage of all topics.
