The producer statement must be from a competent person taking into account the following: 1) All parts of the device shall be properly aligned and not bent, distorted, cut or damaged, in order to force-fit parts together; 2) Worn or damaged parts shall not be used; 3) Parts requiring lubrication shall be lubricated in the course of erection and at proper intervals thereafter; 4) Fastenings and locking apparatus shall be installed where required for safe operation and secured in a proper manner; 5) Makeshift apparatus shall not be used; 6) Suitable artificial lighting shall be installed where necessary for the safety of passengers; 7) The device, and all safety equipment, fences, barriers and other fixtures around it, shall be kept in a good state of repair, and maintained in that condition free from patent defects; 8) The ground on which the device is erected shall be capable of supporting it without substance; 9) Any welding of load bearing parts shall be done by a person who is the holder of a welding certificate appropriate for the type of welding being carried out; 10) Where split pins or taper pins are used in floating spindles, washers shall be provided between the pins and adjacent rubbing surfaces and at all times the correct pins shall be used.
