The Register of Pecuniary Interests

This Register of Pecuniary Interests (the Register) is published pursuant to Section 54A of the Local Government Act (the Act).

The Act requires Masterton District Council to publish a summary of elected members' financial, business and personal interests including certain assets, financial and business associations and gifts they have received annually. Elected members are provided a declaration form to complete annually, once returned to Council officers a summary of the information is collated and published on our website. This Register summarises the information provided by elected members' in their annual declarations in relation to the requirements of the Act which includes the following:
